Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

Special operating conditions or restrictions:

- 1 Since the application proposes to mount its FM antenna at the same height of the co-located existing directional antenna of W290BK, Colebrook, NH, the permittee shall submit an exhibit including a statement from the manufacturer of W290BK's directional antenna stating that the proposed antenna will have no adverse effect on the W290BK's directional antenna pattern.
- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 New Hampshire Public Radio, Inc. requests waiver of 47 C.F.R. Section 73.1125 to operate the proposed facility as a "satellite" of co-owned noncommercial educational FM station WEVO(FM), Facility ID# 48438, Concord, NH. Based upon the specific representations contained therein, the waiver request IS GRANTED. New Hampshire Public Radio, Inc. shall abide by each representation proffered in the waiver request.
