- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 2 Ground system consists of 120 equally spaced, buried, copper radials about the base of tower, each 128 meters in length except where terminated by property boundaries or where intersecting radials are shortened and bonded to a transverse copper strap midway between adjacent towers, plus 120 interspersed radials 30.5 meters in length.
