Special operating conditions or restrictions:

- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 2 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
- 3 Ground system consists of 120 equally spaced, buried, copper radials each 111.8 meters in length about the base of the tower.
- 4 Pursuant to 47 CFR Section 73.3571(k)(1), an AM applicant, permittee, or licensee that has received a dispositive Section 307(b) preference based on proposed service to underserved populations (under Priority (1), Priority (2), or Priority (4)), or service totals (under Priority (4)) is required to construct and operate for a period of four years of on-air operations technical facilities substantially equivalent to the service area on which the Section 307(b) preference was based.
- 5 Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
