- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC quidelines.
- 2 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
- 3 Using Valcom V33085AMCL2 vertical whip antenna, and ground system consists of 120 equally spaced, buried, copper radials about the base of the tower, each 36.6 meters in length.
