- The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.
- 3 ***NOTE TO PERMITTEE***
 - Notwithstanding the grant of this construction permit or the expiration date specified herein, your station's license will automatically expire as a matter of law on December 23, 2016 if the station has not resumed broadcasting before that time. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, Silent Station Authorizations, FCC 96-218 (released May 17, 1996). See also Public Notice, Expedited Processing of Applications Filed By Silent Stations, DA 96-818 (May 22, 1996). Upon resumption of broadcasting, the licensee must notify the Commission. This notice will be in addition to an application for a license to cover this permit.

Special operating conditions or restrictions:

Pursuant to the waiver of 47 CFR Section 74.1233(a)(1) granted herein the permittee shall be subject to a holding period. The permittee may NOT change the AM primary station listed on this authorization. Once a license application is filed to cover this construction permit, this facility is required to rebroadcast this AM primary station for four years. Periods of station silence shall not count toward the fulfillment of this four-year requirement. During this same four year period the permittee may not assign or transfer the construction permit to another party, unless it is to the licensee of the AM station being rebroadcast. Minor modifications of this authorization are permitted, provided the translator will continue to rebroadcast the AM station for which the waiver was granted.
