Special operating conditions or restrictions:

The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BMPED-20110608ACM.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

0.60 kilowatts.

Principal minima and their associated field strength limits:

290 degrees True: 0.057 kilowatts

Pursuant to 47 CFR Section 73.7005(a) the permittee/licensee shall be subject to a holding period. From the grant of the construction permit and continuing until the facility has achieved four years on on-air operations, the permittee/licensee proposing to assign or transfer the construction permit/license to another party will be required to demonstrate the following two factors: that the proposed buyer would qualify for the same number of points as the assignor to transferor originally received; and that consideration received and/or promised does not exceed the assignor's or transferor's legitimate and prudent expenses as defined therein.
