Special operating conditions or restrictions:

- 2 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BPH-19990127IB.

A relative field strength of 1.0 on the composite radiation pattern authorized by BPH-19990127IB corresponds to the following effective radiated power:

50.0 kilowatts.

Principal minima and their associated effective radiated power limits:

25 to 30 degrees True: 11.5 kilowatts
35 degrees True: 12.5 kilowatts
300 to 315 degrees True: 1.2 kilowatts.

- 3 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
