Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

Special operating conditions or restrictions:

- BEFORE PROGRAM TESTS ARE AUTHORIZED, permittee shall submit the results of a complete proof-of-performance to establish the horizontal plane radiation patterns for both the horizontally and vertically polarized radiation components. This proof-of-performance may be accomplished using the complete full size antenna, or individual bays therefrom, mounted on a supporting structure of identical dimensions and configuration as the proposed structure, including all braces, ladders, conduits, coaxial lines, and other appurtenances; or using a carefully manufactured scale model of the entire antenna, or individual bays therefrom, mounted on an equally scaled model of the proposed supporting structure, including all appurtenances. Engineering exhibits should include a description of the antenna testing facilities and equipment employed, including appropriate photographs or sketches and a description of the testing procedures, including scale factor, measurements frequency, and equipment calibration.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, permittee shall submit an affidavit from a licensed surveyor to establish that the directional antenna has been oriented at the proper azimuth.
- BEFORE PROGRAM TESTS ARE AUTHORIZED, permittee/licensee shall submit an affidavit that the installation of the directional antenna system was overseen by a qualified engineer. This affidavit shall include a certification by the engineer that the antenna was installed pursuant to the manufacturer's instructions and list the qualifications of the certifying engineer.
- 4 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by this construction permit.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

1.6 kilowatts.

Principal minima and their associated field strength limits:

50 degrees True: 1.05 kilowatt 140 degrees True: 0.190 kilowatt 160 degrees True: 0.160 kilowatts 200 - 220 degrees True: 0.175 kilowatt

BEFORE PROGRAM TESTS ARE AUTHORIZED, the permittee must submit an exhibit demonstrating that the measured directional antenna pattern complies with the appropriate community coverage provisions of 47 C.F.R. Sections 73.315 or 73.515.

Special operating conditions or restrictions:

- The grant of this application is conditioned on the applicant's agreement to accept any interference caused by any use by the United Nations of its allocation on Channel 206 in New York, New York with maximum facilities of 20 kilowatts and 150 meters antenna height above average terrain, or equivalent; and to take whatever steps are necessary to eliminate any interference caused by the permitee/licensee to such use of the United Nations' channel 206 allocation, including termination of operation if necessary.
- Since the application proposes to mount its FM antenna above the co-located existing directional antenna of W231BP, translator for WJGK(FM), Facility ID# 63934, Newburgh, NY, the permittee shall submit an exhibit including a statement from the manufacturer of W231BP's directional antenna stating that the proposed antenna will have no adverse effect on the W231BP directional antenna pattern.
- Since the application proposes to mount its FM antenna above the co-located existing directional antenna of W219DQ, translator for WLJP(FM), Facility ID# 60900, Monroe, NY, the permittee shall submit an exhibit including a statement from the manufacturer of W219DQ's directional antenna stating that the proposed antenna will have no adverse effect on the W219DQ directional antenna pattern.
- 9 Waiver of 47 C.F.R. Section 73.1125 was previously granted to allow operation of this facility as a satellite operation of the following station:
 - WFGB(FM), Facility ID No. 60896, Kingston, NY, Sound of Life, Inc.
- The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
