- 2 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.

3 ***NOTE TO PERMITTEE***

Notwithstanding the grant of this construction permit or the expiration date specified herein, your station's license will automatically expire as a matter of law on December 20, 2018 if the station has not resumed broadcasting before that time. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, Silent Station Authorizations, FCC 96-218 (released May 17, 1996). See also Public Notice, Expedited Processing of Applications Filed By Silent Stations, DA 96-818 (May 22, 1996). Upon resumption of broadcasting, the licensee must notify the Commission. This notice will be in addition to an application for a license to cover this permit.

4 The permittee/licensee shall, upon completion of construction and during the equipment test period, make proper radiofrequency electromagnetic (RF) field strength measurements on the roof and throughout the building to determine if there are any areas that exceed the FCC guidelines for human exposure to RF fields. Access must be restricted to prevent the exposure of humans to RF fields in excess of the FCC Guidelines (OET Bulletin No. 65, Edition 97-01, August 1997). Furthermore, any areas found to exceed the recommended guidelines must be clearly marked with appropriate visual warning signs which describe the nature of the hazard.
