Special operating conditions or restrictions:

- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- 2 Pursuant to the waiver of 47 CFR Section 74.1233(a)(1) granted herein (or previously granted) the permittee/licensee shall be subject to a holding period. From the grant of the construction permit and continuing until the facility has achieved four years of on-air operations rebroadcasting the AM station identified on this authorization, the permittee/licensee may NOT change the station being rebroadcast by this translator. Periods of station silence shall not count toward the fulfillment of this four-year requirement. During this same four year period the permittee/licensee may not assign or transfer the construction permit/license to another party, unless it is to the licensee of the AM station being rebroadcast. Minor modifications of this authorization are permitted, provided the translator will continue to rebroadcast the AM station for which the waiver was granted.
