Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

- 1 BEFORE PROGRAM TEST AUTHORITY IS AUTHORIZED BY THE COMMISSION PERMITTEE SHALL SUBMIT DOCUMENTATION OF COMPLIANCE WITH THIS SPECIAL OPERATING CONDITION ALONG WITH THE FORM 302, APPLICATION FOR LICENSE, AND THE REQUEST FOR PROGRAM TEST AUTHORITY. THE PERMITTEE SHALL, UPON COMPLETION OF CONSTRUCTION AND DURING THE EQUIPMENT TEST PERIOD, MAKE PROPER RF FIELD STRENGTH MEASUREMENTS THROUGHOUT THE AREA TO DETERMINE IF THERE ARE ANY AREAS THAT EXCEED THE ANSI, EPA AND FCC SPECIFIED GUIDELINES FOR HUMAN EXPOSURE TO RADIOFREQUENCY RADIATION. IF NECESSARY, A FENCE MUST BE ERECTED AT SUCH DISTANCES AND IN SUCH A MANNER AS TO PREVENT THE EXPOSURE OF HUMANS TO RADIOFREQUENCY RADIATION IN EXCESS OF THE AMERICAN NATIONAL STANDARDS INSTITUTE GUIDELINES (OST BULLETIN NO. 65, OCTOBER 1985). THE FENCE MUST BE OF A TYPE WHICH WILL PRECLUDE CASUAL OR INADVERTENT ACCESS, AND MUST INCLUDE WARNING SIGNS AT APPROPRIATE INTERVALS WHICH DESCRIBE THE NATURE OF THE HAZARD. ANY AREAS WITHIN THE FENCE FOUND TO EXCEED THE RECOMMENDED GUIDELINES MUST BE CLEARLY MARKED WITH APPROPRIATE VISUAL WARNING SIGNS.
