THE FENCE MUST BE OF A TYPE WHICH WILL PRECLUDE CASUAL OR INADVERTENT ACCESS, AND MUST INCLUDE WARNING SIGNS AT APPROPRIATE INTERVALS WHICH DESCRIBE THE NATURE OF THE HAZARD. THE PERMITTEE SHALL, UPON COMPLETION OF CONSTRUC-TION AND DURING THE EQUIPMENT TEST PERIOD, MAKE PROPER RF FIELD STRENGTH MEASUREMENTS TO DETERMINE THE AREAS THAT EX-CEED THE ANSI SPECIFIED GUIDELINES. PERMITTEE SHALL SUBMIT DOCUMENTATION OF COMPLIANCE WITH THIS SPECIAL OPERATING CONDITION ALONG WITH THE FORM 302, APPLICATION FOR LICENSE, AND THE REQUEST FOR PROGRAM TEST AUTHORITY.
