- 2 The permittee/licensee must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 Permittee has specified use of a TEL Model ANT90D, vertically polarized antenna to demonstrate that no predicted actual interference to Station WWL-FM will occur as allowed by 47 CFR Section 74.1204(d). If any other type or size of antenna is to be used with the facilities authorized herein, an application for modification of this permit must be filed using Form FCC 349. The application must include a revised showing to demonstrate continued compliance with Section 74.1204(d).
