Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. - 3 The permittee has specified the use of an ERI/Jampro rototiller (EPA Type 3), 8 section antenna to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed with the FCC Form 302-FM, application for license, BEFORE program tests will be authorized. This request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.

Special operating conditions or restrictions:

- 4 Houston Christian Broadcasters, Inc. was granted a waiver of 47 C.F.R. § 73.1125 to allow the operation of this station as a "satellite" of co-owned noncommercial educational FM Station KHCB-FM, Houston, Texas (Facility ID No. 27702). See License BLED-20070613AAU, granted October 8, 2008. Grant of this waiver is continued. Houston Christian Broadcasters, Inc. must abide by each representation proffered in the waiver request.
