- 2 Calvary Chapel of Twin Falls, Inc. was granted a waiver of 47 C.F.R. § 73.1125 to allow the operation of this station as a "satellite" of co-owned noncommercial educational FM Station KAWZ(FM), Twin Falls, Idaho (Facility ID No.: 8414). See License BLED-19950620KC, granted October 10, 1995, re-issued March 18, 2009. Grant of this waiver is continued. Calvary Chapel of Twin Falls, Inc. shall abide by each representation proffered in the waiver request.

- 3 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by Construction Permit BPED-20091221AFJ.

A relative field strength of 1.0 on the composite radiation pattern authorized by Construction Permit BPED-20091221AFJ corresponds to the following effective radiated power:
