 BEFORE PROGRAM TESTS COMMENCE, SUFFICIENT MEASUREMENTS SHALL BE MADE TO ESTABLISH THAT THE OPERATION AUTHORIZED IN THIS CONSTRUCTION PERMIT IS IN COMPLIANCE WITH THE SPURIOUS EMISSIONS REQUIREMENTS OF SECTIONS 73.317(B) THROUGH 73.317(D) OF THE COMMISSION'S RULES. ALL MEASUREMENTS MUST BE MADE WITH STATIONS WRR, KHYI, AND BPED-830630AF SIMULTANEOUSLY UTILIZING THE ERI TYPE 1053-6P ANTENNA. THESE MEASUREMENTS SHALL BE SUBMITTED TO THE COMMISSION ALONG WITH THE FORM 302 APPLICATION FOR LICENSE.

2. CONDITION FOR BEAM TILT ANTENNA
 PERMITTEE SHALL SUBMIT A COPY OF THE VERTICAL PLANE PATTERN FOR THE -0.65 DEGREE BEAM TILT ANTENNA WITH THE FORM 302 APPLICATION FOR LICENSE.
