PERMITTEE SHALL SUBMIT DOCUMENTATION OF COMPLIANCE WITH THIS SPECIAL OPERATING CONDITION ALONG WITH THE FORM 302, APPLICATION FOR LICENSE, AND THE REQUEST FOR PROGRAM TEST AUTHORITY.
