These measurements shall be submitted to the Commission along with the FCC Form 350-FM application for license.
- \*\*\*NOTE TO PERMITTEE\*\*\*  
 Notwithstanding the grant of this construction permit or the expiration date specified herein, your station's license will automatically expire as a matter of law on April 16, 2016 if the station has not resumed broadcasting before that time. See Pub. Law No. 104-104, 110 Stat. 56, Section 403(1) (1996) and Order, Silent Station Authorizations, FCC 96-218 (released May 17, 1996). See also Public Notice, Expedited Processing of Applications Filed By Silent Stations, DA 96-818 (May 22, 1996). Upon resumption of broadcasting, the licensee must notify the Commission. This notice will be in addition to an application for a license to cover this permit.

Special operating conditions or restrictions:

- 3 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
  
- 4 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.
