This request should be submitted at least 10 days prior to the date on which program tests are desired to commence. This request must contain documentation which demonstrates compliance with the following special operating condition(s):
- The permittee/licensee shall, upon completion of construction and during the equipment test period, make proper radiofrequency electromagnetic (RF) field strength measurements on the roof and throughout the building to determine if there are any areas that exceed the FCC guidelines for human exposure to RF fields. Access must be restricted to prevent the exposure of humans to RF fields in excess of the FCC Guidelines (OET Bulletin No. 65, Edition 97-01, August 1997). Furthermore, any areas found to exceed the recommended guidelines must be clearly marked with appropriate visual warning signs which describe the nature of the hazard.
- Documentation demonstrating compliance with the special operating condition(s) shall be submitted at the time of the filing of FCC 302-FM, Application for License.

Special operating conditions or restrictions:

BEFORE PROGRAM TESTS COMMENCE, sufficient measurements shall be made to establish that the operation authorized in this construction permit is in compliance with the spurious emissions requirements of 47 C.F.R. Sections 73.317(b) through 73.317(d). All measurements must be made with all stations simultaneously utilizing the shared antenna. These

measurements shall be submitted to the Commission along with the FCC Form 302-FM application for license.

Permittee has specified use of a custom 2-bay Shively 6014 Panel Antenna. It is circularly polarized and provides the capability of providing both directional and nondirectional antenna patterns through use of a complex feed system provided by Shively Labs to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed in conjunction with FCC 302-FM, application for license, BEFORE program tests will be authorized. The request must include a revised RF field showing to demonstrate continued compliance with the FCC quidelines.

The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
