Special operating conditions or restrictions:

- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 2 The proposed antenna shall be excited with a symmetrical folded unipole feed, utilizing a minimum of three folds. Slant wire is not permitted.
- 3 Ground system consists of 120 equally spaced, buried, copper radials which are 50.3 meters in length.
- 4 Permittee/Licensee shall accept such interference as may be imposed by other existing 250 watt Class C stations in the event that they are subsequently authorized to increase power to 1000 watts.
