Special operating conditions or restrictions:

- The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based on the use of the antenna specified herein. If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R. Section 73.1690(c), the subsequent FCC Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC quidelines.
- Warning signs which describe the radiofrequency electromagnetic field hazard must be posted. Access must be restricted to prevent the exposure of humans to RF emissions in excess of the FCC radiofrequency radiation guidelines (OET Bulletin 65, Edition 97-01, released August 1997).
- Advance Minstries, Inc. d/b/a New Life Christian School was granted a waiver of 47 C.F.R. § 73.1125 to allow the operation of this station as a "satellite" of co-owned noncommercial educational FM Station KNLB(FM), Lake Havasu City, Arizona (Facility ID No.: 48504). See BAPED-20130627ACA, granted January 23, 2014. Grant of this waiver is continued. Advance Ministries, Inc. d/b/a New Life Christian School must continue to abide by each representation proffered in that waiver request.
