- 2 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BPED-19980317MF.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

0.100 kilowatts.

Principal minima and their associated field strength limits:

120 clockwise to 260 degrees True: 3.20 watts

- 4 Joy Christian Ministries Church requests waiver of 47. C.F.R.
