Special operating conditions or restrictions:

BEFORE PROGRAM TESTS COMMENCE, sufficient measurements shall be made to establish that the operation authorized in this construction permit is in compliance with the spurious emissions requirements of 47 C.F.R. Sections 73.317(b) through 73.317(d). All measurements must be made with all stations simultaneously utilizing the shared antenna. These measurements shall be submitted to the Commission along with the FCC Form 350-FM application for license.

4 Since the application proposes to mount its antenna above the co-located existing directional antennas of:

K237CK, Riviera Etc., AR (Facility ID No. 965) K242AS, Bullhead City Etc., AR (Facility ID No. 30447) K248BJ, Mohave Valley, AR, (Facility ID No. 147059),

the permittee must submit, with the FCC Form 350, application for license, an exhibit including a statement from the manufacturer of each directional antenna listed above, stating that the proposed antenna will have no adverse effect on the aforementioned directional antenna patterns.
