Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. - 2 The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of the FCC guidelines.

## Special operating conditions or restrictions:

- 3 The permittee has specified the use of a vertically polarized only antenna to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed with the FCC Form 302-FM, application for license, BEFORE program tests will be authorized. This request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.
