Special operating conditions or restrictions:

BEFORE PROGRAM TESTS COMMENCE, sufficient measurements shall be made to establish that the operation authorized in this construction permit is in compliance with the spurious emissions requirements of 47 C.F.R. Sections 73.317(b) through 73.317(d). All measurements must be made with all stations simultaneously utilizing the shared antenna. These measurements shall be submitted to the Commission along with the FCC Form 350-FM application for license.

Warning signs which describe the radiofrequency electromagnetic field radiation hazard must be posted at appropriate intervals. Access must be restricted to prevent the exposure of humans to RF emissions in excess of the FCC guidelines (OET Bulletin 65, Edition 97-01, released August 1997). Permittee shall submit documentation of compliance with this special operating condition when filing FCC Form 350, application for license.
