Special operating conditions or restrictions:

1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

Warning signs which describe the radiofrequency exposure hazard must be posted at appropriate intervals and maintained. Access must be restricted to prevent the exposure of humans to FR emission in excess of the FCC guidelines (OST Bulletin No. 65, Edition 97-01, August, 1997). Special operating conditions or restrictions:

2 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by this construction permit.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

20.0 kilowatts.

Principal minima and their associated field strength limits:

70 to 80 degrees True: 0.630 kilowatts

3 The applicant has requested waiver of 47 C.F.R. § 73.1125 to operate the proposed facility as a "satellite" of co-owned noncommercial educational FM Station KLVR(FM), Santa Rosa, California, (Facility ID No.: 18801). Based upon the specific representations contained therein, the waiver request IS GRANTED. The applicant shall abide by each representation proffered in the waiver request.
