This authorization is re-issued on May 23, 2012, to reflect the grant of a Main Studio Satellite Waiver (see Special Operating Condition No. 3).

- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- 3 Illinois Bible Institute, Inc., requests waiver of 47 C.F.R. §73.1125 to operate the proposed facility as a "satellite" of co-owned noncommercial educational FM station WCIC(FM), Pekin, Illinois (Facility ID No. 28301). Based on the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
