- 3 The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BMPED-20130531AIH.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

10.5 kilowatts.
