The construction permits for W259CZ (Fac. Id. 200628) and W286DO (Fac. Id. 202719) expire on January 16, 2021 and June 8, 20121, respectively. Commission rules which became effective on February 16, 1999, have a bearing on these construction permit. See Streamlining of Mass Media Applications, Report and Order, MM Docket No. 98-43, 13 FCC Rcd 23056 (1999). Pursuant to these rules, consummation of the assignment consented to herein will not extend the expiration date of the permits. The construction permits will be subject to automatic forfeiture unless construction is complete and applications for license to cover are filed prior to expiration.

The FM Translator Licensee must notify the Federal Communications Commission, Office of the Secretary, 445 12th Street, S.W., Washington, DC 20554 of any change in the station that will be rebroadcast. The parties should also notify Robert Gates via email at Robert.Gates@fcc.gov. See 47 C.F.R. §74.1284.

Under authority of the Communications Act of 1934, as amended, the consent of the Federal Communications Commission is hereby granted to the transaction indicated above.
