Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

THIS REQUEST SHOULD BE MADE AT LEAST 10 DAYS PRIOR TO THE DATE ON WHICH PROGRAM TESTS ARE DESIRED TO COMMENCE. THIS REQUEST MUST CONTAIN DOCUMENTATION WHICH DEMONSTRATES COMPLIANCE WITH THE FOLLOWING SPECIAL OPERATING CONDITION:

PERMITTEE SHALL SUBMIT A STATEMENT CERTIFYING THAT A JOINT AGREEMENT AMONG ALL THE MULTIPLE STATIONS COLOCATED AT YOUR TRANSMITTER SITE WILL BE IN EFFECT TO REDUCE OR CEASE OPERATION TO PROTECT PERSONS AUTHORIZED ACCESS TO THE SITE, TOWER OR ANTENNA FROM EXCESSIVE RADIO-FREQUENCY RADIATION AS OUTLINED IN OST BULLETIN NO. 65, OCTOBER, 1985.
