This authorization is re-issued September 11, 2008, to reflect the grant of a Main Studio Waiver see (Special Operating Condition #5)

Subject to the provisions of the Communications Act of 1934, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this license, the licensee is hereby authorized to use and operate the radio transmitting apparatus herein described.

17.33 KW AT 5 DEGREE TRUE  
23.76 KW AT 90 DEGREE TRUE  
26.5 KW AT 345 DEGREE TRUE

Special operating conditions or restrictions:

- 3 In addition, neither radiation component shall increase at a rate exceeding 0.2 dB per degree from the azimuths of restricted radiation specified above nor exceed a maximum-to-minimum ratio of 15 dB. The rms of the vertically polarized radiation pattern shall not exceed that of the horizontally polarized radiation pattern.
  
- 4 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
  
- 5 Georgia Public Telecommunications Commission requests waiver of 47. C.F.R. Section 73.1125 to operate the proposed facility at Georgia Public Telecommunications Commission's headquarters located at 260 14th Street, N.W., Atlanta, Georgia. Based upon the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
