Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

- 3 The permittee shall submit a copy of the vertical plane radiation pattern for the beam tilt antenna with the FCC Form 302-FM Application for License.

- 4 Since the application proposes to mount its FM antenna above the co-located existing directional antenna of WJHM(FM), Daytona Beach, FL, the permittee shall submit an exhibit including a statement from the manufacturer of WJHM's directional antenna stating that the proposed antenna will have no adverse effect on the WJHM directional antenna pattern.
