(Facility Id#135228) may submit a minor change application incorporating a voluntary time-share agreement with Ebenezer Pentecostal Radio Service (Facility Id#134678) within 30 days of the release date of the order. Failure to submit a time-share agreement the applicants will be eligible for equal, successive license terms of 4 years.
