Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

- 1 Pursuant to the grant of this construction permit and the authority found in Sections 4(i), 5(c)(1), 303 and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, the FM Table of Allotments, 47 C.F.R. Section 73.202(b), IS AMENDED as follows:

Pursuant to Section 316(a) of the Communication Act of 1934, as amended, license BLH-20001129AAB IS MODIFIED to specify operation on Channel 239C2 in lieu of Channel 239C3.

- 2 BEFORE PROGRAM TESTS COMMENCE, sufficient measurements shall be made to establish that the operation authorized in this construction permit is in compliance with the spurious emissions requirements of 47 C.F.R. Sections 73.317(b) through 73.317(d). All measurements must be made with all stations simultaneously utilizing the shared antenna. These measurements shall be submitted to the Commission along with the FCC Form 302-FM application for license.
- 3 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

Special operating conditions or restrictions:

- 4 PROGRAM TESTS FOR KLEY-FM(FACILITY ID #55414) WILL NOT COMMENCE ON CHANNEL 239C2 WITH FACILITIES AUTHORIZED HEREIN UNTIL PROGRAM TESTS FOR KVWG-FM(FACILITY ID #52047) COMMENCE ON CHANNEL 237A WITH THE FACILITIES AUTHORIZED IN BPH-20060321ABZ AND A LICENSE WILL NOT BE GRANTED FOR KLEY-FM ON CHANNEL 239C2 WITH FACILITIES AUTHORIZED HEREIN UNTIL A LICENSE IS GRANTED FOR KVWG-FM ON CHANNEL 237A WITH THE FACILITIES AUTHORIZED IN BPH-20060321ABZ.
