- Warning signs that describe the radiofrequency electromagnetic (RF) field hazard must be posted at appropriate intervals surrounding the antenna site and at each gate on access roads to the site. These access gates must be locked whenever authorized personnel are not present. Measures must be taken so that persons who are authorized access to the site are not exposed to levels in excess of the FCC Guidelines (OET Bulletin No. 65, Edition 97-01, August 1997). Permittee shall submit documentation of compliance with this special operating condition when filing Form FCC 302-FM, application for license.
- The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
