Special operating conditions or restrictions:

- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 2 Gound System:

The auxiliary antenna shares the main WCBS antenna ground system and will be modified to include a 7.32 meter by 7.32 meter ground screen. The existing ground system consists of 120 equally spaced buried copper radials extending outward from the main antenna and terminated in the salt water beyond the low water line of the island plus a 12.2 meter by 12.2 meter gound screen.
