Special operating conditions or restrictions:

- 1 Self-supported folded unipole antenna with six skirt wires. Ground system consists of 120 equally spaced, buried copper radials 32 - 75 meters in length except where terminated by property boundaries, plus 120 interspersed radials 15 meters in length, plus a 10 meter square copper ground screen about the base of the tower.

- 2 The antenna shall be excited with a symmetrical folded unipole feed, utilizing a minimum of three folds. Slant wire is not permitted.

- 3 Licensee must submit the information required pursuant to 47 CFR Section 73.99(e) if a Presunrise (PSRA) and/or Postsunset Authorization (PSSA) is desired. These authorizations are granted by the Commission based upon the currently licensed facility. Any previously granted PSRA/PSSA authorizations referenced to an older licensed site are no longer valid.
