A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

0.43 kilowatts(H&V).

80 to 90 degrees True: 0.0140 kilowatts 230 degrees True: 0.0180 kilowatts

- 3 The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based upon the usage of the antenna specified herein. - 4 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
