Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration.  Notwithstanding the grant of this construction permit or the expiration date specified herein, your station's license will automatically expire as a matter of law on July 31, 2014 if the station has not resumed broadcasting before that time. Upon resumption of broadcasting, the licensee must notify the Commission.

Special operating conditions or restrictions:

- 3 During installation of the antenna authorized herein, AM Station(s) listed below shall determine operating power by the indirect method. Upon completion of the installation, antenna impedance measurements on the AM antenna shall be made and, prior to or simultaneous with the filing of the application for license to cover this permit, the results submitted to the Commission (along with a tower sketch of the installation) in an FCC Form 302-AM application for the AM station to return to the direct method of power determination.

- 5 Permittee shall submit a statement certifying that a fence has been constructed at least one meter from the base of the tower and in such a manner as to prevent the exposure of humans to radiofrequency electromagnetic fields in excess of the FCC Guidelines in OET bulletin No. 65, Edition 97-01 August 1997. The fence must be of a type which will preclude casual or inadvertent access, and must include warning signs at appropriate intervals which describe the nature of the hazard.
- 6 Documentation demonstrating compliance with the preceding special operating condition shall be submitted at the time of filing of FCC Form 302-FM.
