Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

ALL MEASUREMENTS MUST BE MADE WITH STATIONS WFYV AND WIVY-FM SIMULTANEOUSLY UTILIZING THE ALAN DICK & CO. SHARED ANTENNA. THESE MEASUREMENTS SHALL BE SUBMITTED TO THE COMMISSION ALONG WITH THE FORM 302 APPLICATION FOR LICENSE.

THE PERMITTEE SHALL SUBMIT A COPY OF THE VERTICAL PLANE PATTERN FOR THE -0.5 DEGREE BEAM TILT ANTENNA ALONG WITH THE FORM 302 APPLICATION FOR LICENSE.
