A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

1.90 kilowatts.

Principal minima and their associated field strength limits:

150 degrees True: 0.42 kilowatt 160 degrees True: 0.47 kilowatt
