Special operating conditions or restrictions:

- 1 Program tests for FM Booster KUDD-FM4, Magna, Utah, rebroadcasting primary FM station KUDD, Roy, Utah (BLH-19831017AD) will not commence on Channel 300 with the facilities specified in this construction permit BNPFTB-20010913ABQ until FM Booster KUDD-FM3, Provo, Utah (BLFTB-20001221ACL) ceases operation. A license application to cover this construction permit for KUDD-FM4 (BNPFTB-20010913ABQ) will not be granted until cancellation of the license and deletion of call sign for FM Booster KUDD-FM3 is final.
- 2 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.

Special operating conditions or restrictions:

- 3 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
