Special operating conditions or restrictions:

- 1 Licensee shall be responsible for satisfying all reasonable complaints of blanketing interference within the 1 V/m contour as required by Section 73.88 of the Commission's rules.
- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 Ground system consists of 120 equally spaced, buried, cooper radials about the base of the tower, each 73.5 meters in length.
- Grant of this license application is conditioned on continuous operations of the licensed facility for the twelve-month period following grant. The failure of the facility to so will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts presumption that authorized facilities were temporarily constructed.
