- 1 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.
- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

Special operating conditions or restrictions:

- 3 Permittee has specified use of a TEL Model ANT90D directional, vertically polarized antenna to demonstrate that no predicted actual interference to Stations KJCQ and KPJP will occur as allowed by 47 CFR Section 74.1204(d). If any other type or size of antenna is to be used with the facilities authorized herein, an application for modification of this permit must be filed using Form FCC 349. The application must include a revised showing to demonstrate continued compliance with Section 74.1204(d).
