

DECLARATION

Yo, Quilvio N. Perdomo Declare under penalty of perjury the following information are true to my best knowledge and belief.

John Fuller the owner of WKKB a competitor station for WSTL & W235CN in the Market of Providence, RI. is the owner of Red wolf Broadcasting the licensee of WJJF Montauk, NY. Who's manipulated the actual FCC procedure for complaints of interference to shutdown W235CN 94.9 in Providence, RI.

From day 1, in Radio Sharon we have submitted responsibly responds to all complaints with intends to remediate and filed On/Off tests of all alleged interference locations demonstrating the complaints are false.

Radio Sharon also manifest thru this declaration that John Fuller not only has intended to shutdown W235CN thru his file of Informal Objection, He also claimed violation of a non compete, further more intended to buy the translator w235cn, further more intended to buy WSTL our primary station, even more intended to buy the building where WSTL & W235CN is operating the studios and offices, there are more he met with our program director as I explained in a past declaration, consequently we fired and today he named Jose Rocha as Program Director. Furthermore we have testimonies of some clients not limited to Providence fire restoration where they defamed WSTL & W235CN and offered to make a better deal to our clients.

Here is more during the transaction of WSTL to Diaz Holdings, Rev. Pastor John L. Pfeffer, Jr. previous owner of WSTL informed us that John Fuller called him several times and left messages asking to call him back but Rev. Pastor John never returned the calls. But in other occasion like a year ago John Fuller offered Pastor John to buy WSTL our primary station and fortunately Pastor John rejected to sell it.

Even more John Fuller contacted FCC thru another procedure to complaint against W235CN alleging we're operating over power, a received a visit of an inspector of FCC who made test and check our transmitter to verify if we're

using over power, we never use more power than 55watts except some days while we are making some tests over the complaints to verify they are false.

And lately our frequency W235CN is receiving some statics and noise at the same city of Providence where our signal is suppose to be local, I think that John Fuller may have turns-on another transmitter at our frequency with noises and statics to create some noise interference locally in our signal, we're going to investigate to detect any illegal transmitter in the area turned on in our frequency with statics sounds to make our signal noise in the city of license no other station just statics sound in our frequency locally.


Evidently John Fuller has done all possible procedures and anti-ethic matters to shutdown W235CN.
