WITHDRAWAL OF INFORMAL OBJECTION

Triangle Access Broadcasting, Inc. (“Triangle”), hereby withdraws its September 27, 2019, Informal Objection¹ to the renewal of Our Three Sons Broadcasting, LLP's (“OTSB”) translators. On November 30, 2019, OTSB submitted an Opposition to Informal Objection² (“Opposition”) demonstrating that it has cured the reason for Triangle's objection.

For a significant time period between 2016 until October 20, 2019, OTSB had been feeding both of its W232AX (Facility ID 50778) and W281BE (Facility ID 153412) translators from primary stations airing “The Bridge” programming.³ Triangle objected because “same programming” triggers the technical need rule (regardless of whether translators are being fed by the same primary signal).⁴ No showing of technical need was ever submitted.

When OTSB changed the programming of WRHM-HD3 on October 20, 2019, it caused the programming on W232AX to differ from the programming on W281BE. Along with OTSB's plan to continue separate programming on WRHM's digital subchannels, Triangle is satisfied that OTSB's translators are now licensable. If, however, a plan to transmit the same programming over the significantly overlapped translators reemerges, Triangle believes a demonstration of technical need with greater detail than is provided in the Opposition would be required.

Neither Triangle nor its principals has received money or other consideration, and no agreements have been made in connection with this withdrawal.
