INFORMAL OBJECTION

Triangle Access Broadcasting, Inc. (“Triangle”), pursuant to 47 C.F.R. §73.3587, objects to grants of both of the above-referenced applications. On October 2, 2019, Robert Hunnicutt dba Robert L. Hunnicutt (“Hunnicutt”) submitted an application for renewal of FM translator W279BY (Facility ID 151444) retransmitting WKZK(AM) (Facility ID 24696). This application was amended on October 7, 2019, to claim a nonprofit exemption. On November 29, 2019, Edgewater Broadcasting, Inc. (“Edgewater”) submitted an application for renewal of FM translator W255AS (Facility ID 151894) that is also retransmitting WKZK. Triangle objects because W255AS is a same-area translator to W279BY while a technical need has not been demonstrated.¹ Triangle further objects because the applications claim inapplicable nonprofit fee exemptions.

As shown in Exhibit A, essentially all of the W255AS service area is common with the area served by W279BY. As Hunnicutt (via alter ego Gospel Radio, Inc.) and Edgewater each operate translators, and as Edgewater has an established business relationship to Hunnicutt (Edgewater sold W279BY to Hunnicutt), Section 74.1232(b) requires showings of technical need to retransmit the same programming in the same area. The Bureau should not renew licenses for same-area translators without technical need showings.

In his application, Hunnicutt claims that he is exempt from both application fees and regulatory fees due to being nonprofit. Individuals cannot be nonprofit applicants, and primary station WKZK is a commercial station.² Neither of the applicable qualifications, nonprofit ownership and transmitting NCE programming, are met in order for Hunnicutt to claim fee exemptions.³ The Bureau should review the extent to which Hunnicutt has inappropriately availed himself of fee exemptions during the preceding license term. The Bureau should also withhold processing on the W279BY renewal application that was tendered without an application fee.

In W255AS renewal application, Edgewater claims that it is exempt from regulatory fees due to being a nonprofit organization. The unrelated business purpose of translating commercial WKZK falls outside the umbrella of Section 501(c)(3) exemptions.⁴ Section 501(c)(3) nonprofit entities are “organized and operated exclusively for religious, charitable, [...] or educational purposes” (emphasis added).⁵ While nonprofits may engage in limited unrelated business activities, a trade or business is related to exempt purposes “only when the conduct of the business activities has causal relationship to achieving exempt purposes (other than through the production of income). The causal relationship

must be substantial.”⁶ Just as nonprofits must pay taxes on income from unrelated business operations,⁷ regulatory fees must apply for facilities that are not substantially related to a charitable, educational or other purpose that is the basis for an organization's nonprofit status. The public and competing broadcasters are harmed by Edgewater not rightfully paying regulatory fees for its commercial enterprises.

Triangle has analyzed Edgewater's radio broadcast licenses and found that, as of February 17, 2020, 76% of its licenses are commercial. As shown in Exhibit C, out of 51 licensed stations, 39 are commercial FM translators.⁸ Edgewater should have properly declared its facilities used for an unrelated commercial purpose to the Managing Director.⁹ Edgewater should have also declared the general change of status in its organization when it became substantially commercial. Edgewater can clearly no longer faithfully claim that it is a nonprofit entity, and the Bureau should require updated verification of its nonprofit status.

For the above reasons, the subject FM translators are not eligible to be renewed. The Bureau should not renew same area translators, nor should it renew facilities where application and regulatory fees have been evaded.

47 CFR 74.1232 evaluation of WKZK Translators

■ Procedural Overview:

1. From reference coordinates for each station, calculate HAAT using 50 evenly spaced points between 3 and 16 km along each of 360 radials.
Elevation data is from Wolfram Research curated database and is believed to be the best available at the time of the analysis. [Wolfram|Alpha Knowledgebase 2020]
2. Compute F(50,50) 60 dBu service contours using FCC Curves program.
3. Determine if contours overlap by more than 50%.

Setup FCC CURVES module access from Mathematica and Initialize

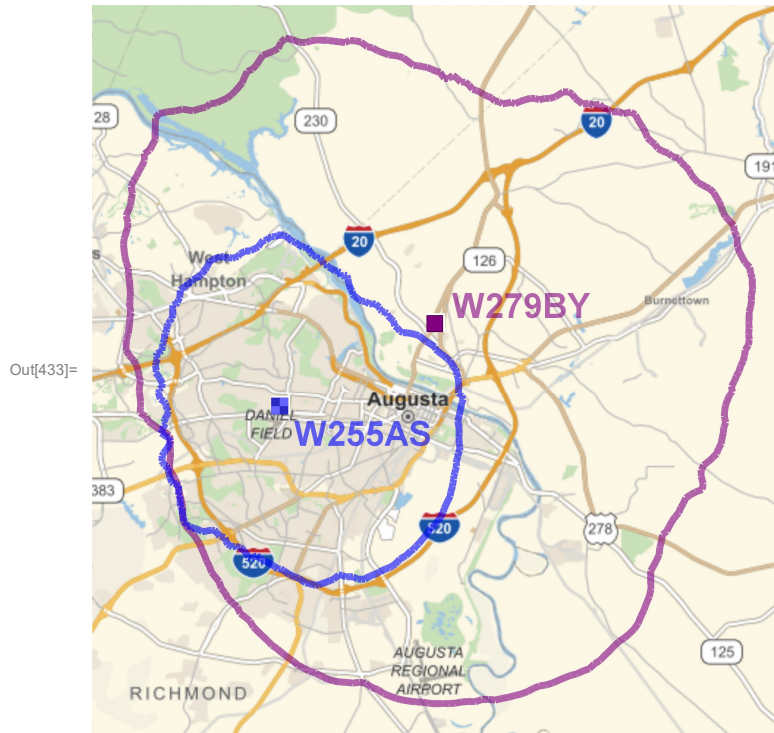
