OPPOSITION TO INFORMAL OBJECTION


Marion R. Williams, by its attorney, and pursuant to Section 73.3587 of the Commission's rules, hereby respectfully submits its "Opposition to Informal Objection" with respect, to the "Informal Objection", as characterized by Commission Staff, to the above-referenced renewal application of WONG(AM), Canton, Mississippi filed by Mark Jones. In support thereof the following is shown:

1. Mr. Jones' only allegation, totally unsupported by ANYTHING, consists of the sentence: "WONG 1150 AM has been off the air for many months." Mr. Jones is either delusional or less than honest.
2. Attached hereto is the Declaration of Frederick Sanders, Chief Engineer of WONG, who states that WONG has not been off the air for anytime in at least the last year except for routine maintenance.
3. Also attached hereto are the letters of Dr. William Truly, the Mayor of Canton, Anthony Denton and Keith B. Warfield, all listeners of WONG who reside in the listening area and who state that the station is on the air and has been for at least 6 months.
4. Consequently, Mr. Jones allegation must be rejected. No evidence has been presented to show that the station has been off the air. The licensee has submitted documentation from listeners and WONG's Chief Engineer that the station IS and WAS on the air.

WHEREFORE, B+ Broadcasting, LLC respectfully requests that the Commission grant its Informal Objection and dismiss with prejudice the above-referenced application of S Content Marketing, LLC.



2. Radio Station WONG has been operating continuously for the past year, at least, and has not been silent other than for routine maintenance.


