**WITHDRAWAL OF INFORMAL OBJECTION**

Triangle Access Broadcasting, Inc. (“Triangle”) hereby withdraws its Informal Objection<sup>1</sup> to the captioned Beasley Media Group Licenses, LLC's (“Beasley”) Application for Renewal of License. On October 7, 2021, Beasley filed a Further Supplement to Triangle's Objection that provided information indicating that its translators are no longer duplicating programming over substantially the same area.<sup>2</sup> Triangle has further confirmed that Beasley is also no longer duplicating programming on its Detroit full power FM stations as part of its unsound initial attempt to respond to Triangle's objection, an attempt that ignored the established “same programming” applicability of the technical need rule and wasted yet additional valuable and limited spectrum.<sup>3</sup> As Beasley has begun providing an additional program choice to the market to address Triangle's concerns Triangle believes it to be appropriate to withdraw its Objection to the renewals of Beasley's stations.
