Informal Objection

Good morning,

I am writing to file an informal objection to Casa de Destino's application for a construction permit for a new Noncommercial Educational FM station in Bernardsville, New Jersey. In Casa de Destino's application, the applicant certified that they qualify as an "established local applicant". However, the applicant does not meet the criteria, as defined in 47 CFR § 73.7000.

In Casa de Destino's attachment to their application titled "Established Local Applicant.New Jersey.pdf", the applicant states that they qualify as an established local applicant as their headquarters are "located at 94 Old Camplain Rd., Hillsboro [sic], New Jersey." However, as I will demonstrate, there is ample evidence to show that this is not the organization's headquarters, including the applicant's own statements. In fact, in the attachment titled "Local Applicant.pdf" to Casa de Destino's application for a construction permit for a new Noncommercial Educational FM station in Bernardsville, New Jersey, the applicant states "The applicant does not qualify as an established local applicant under Section 73.7000 of the Commission's Rules.", essentially conceding that they are not entitled to points as an established local applicant, and contradicting their response to the question as to whether they qualify as a local applicant pursuant to 47 CFR Section 73.7000 and their statement in attachment titled "Established Local Applicant.New Jersey.pdf". As such, Casa de Destino does not qualify as an established local applicant and is not entitled to the points an established local applicant would be granted.

While Casa de Destino claimed in their application for a construction permit for a new

Noncommercial Educational FM station in Bernardsville, New Jersey that their headquarters were in “Hillsboro [sic], New Jersey” (actual name of municipality is Hillsborough, New Jersey), in attachment titled “Established Local Applicant.Texarkana.pdf” to their application for a construction permit for a new Noncommercial Educational FM station in Nash, Texas (file No.: 0000167614), Casa de Destino stated that their headquarters are “located at 8515 North Stateline Ave., Texarkana, TX 77503.” By all evidence, it is their statement that their headquarters are in Texarkana that is accurate, and not their claim of having their headquarters in New Jersey.

A tax exempt organization search on the IRS's website shows Casa de Destino, Inc. as being located in Texarkana, TX. Likewise, a Texas tax-exempt entity search on the Texas State Comptroller's website for Casa de Destino showed the organization as being located in Texarkana, TX. However, a search on the New Jersey Division of Consumer Affairs' NJ DCA Charities Portal yielded no results for Casa de Destino, and neither did a search for the organization's alternate name as listed with the IRS, “Evangelistic Ministry Jesus Christ is Lord Inc”. Screenshots of these search results are presented at the end of this document. Additionally, Texarkana is listed as the location of Casa de Destino, Inc. on its license for KUMB in Hollywood, Mississippi (facility ID: 175589).

In Casa de Destino's attachment titled “Established Local Applicant.Texarkana.pdf” to their application for a construction permit for a new Noncommercial Educational FM station in Nash, Texas, documents were presented from the Texas Office of the Comptroller and the IRS to show that their headquarters are in Texarkana. However, the only document presented to support the claim that the headquarters are in “Hillsboro [sic], New Jersey” is an email from the owner of 94 Old Camplain Rd. stating that they had leased space to “Manuel Pimentel and his organization Casa de Destino Inc”, along with the property owner's opinion that it has been used as its headquarters. However, the mere leasing of property is insufficient evidence that the location in Hillsborough, New Jersey is its headquarters.

As such, Casa de Destino's own statement in “Local Applicant.pdf” where they conceded “The applicant does not qualify as an established local applicant under Section 73.7000 of the Commission’s Rules.” should be accepted, and they should not be given three points for being an established local applicant.
